Ms Lyons has a strong depth of experience in corporate finance and investment banking, specialising in the natural resource sector. She has held a number of senior executive positions in corporate finance and investment banking based in New York, including Director, Investment Banking, Resources and Energy Group with HSBC Securities, where she was the senior coverage officer responsible for the US power and utilities sector. Her other previous roles include Vice President, Investment Banking with Deutsche Banking Securities, Inc. and Associate, Investment Banking, with Bear, Stearns & Co., Inc. Prior to joining LMM, she was a Principal at Scientia Group, a private consultancy focused on cross-border M&A and financing transactions.

Ms Lyons holds an MBA from Duke University's Fuqua School of Business. She has a BA Economics from Smith College and attended the London School of Economics.

Commenting on the appointment, Centaurus' Chairman, Mr Didier Murcia, said:

"We are delighted to announce the appointment of Sheila Lyons to the Centaurus Board. LMM has emerged as a cornerstone shareholder of Centaurus following our recently completed \$26 million capital raising and we are very pleased to have secured the support and involvement of a group of this calibre as we move towards production in Brazil."
